What is Inclusive Education?

The definition of inclusion states that all students:

- are presumed competent
- are welcomed as valued members of all general education classes and extra-curricular activities in their local schools
- fully participate and learn alongside their same age peers in general education instruction based on the general education curriculum, and
- experience reciprocal social relationships.



IDEA

"To the maximum extent appropriate, children with disabilities, including children in public or private institutions or other care facilities, must be educated with children who are not disabled. Further, special classes, separate schooling, or other removal of children with disabilities from the regular educational environment may occur only when the nature or severity of the disability of a child is such that education in regular classes with the use of supplementary aids and services cannot be achieved satisfactorily."





AT Device

Any item, piece of equipment, or product system, whether acquired commercially off the shelf, modified, or customized that is used to increase, maintain, or improve functional capabilities of a person with a disability.

AT Service

Any service that directly assists the person with a disability in the selection, acquisition, or use of an assistive technology device.

- Evaluate/assess the student
- Acquire the device or tool
- Customize or modify
- Coordinate with other therapies or services
- Training the student and student's family
- Training other adults (employers, professionals, caregivers, etc)

More than Checking a Box

The IEP team must consider the following for the student:

- ☐ The communication needs of the student.
- ☐ The need for assistive technology devices and services for the student.


- Present Levels (PLAAFP)
